As the owner and/or authorized agent of the pet described above, I certify that I understand the following conditions pertaining to the boarding of my pet:

### **Veterinary Fees**

You will be responsible for all veterinary fees that are incurred for boarding, vaccinations, examination, medications, or treatments for your pet during the duration of the boarding stay. If it becomes necessary to examine, medicate or medically treat your pet, whether for health reasons or to facilitate the safe handling of your pet, our veterinarians and staff will act accordingly. New patients will receive a comprehensive examination for a fee of \$45. This is to ensure that all boarders are healthy and do not pose a health threat to any other pets in the kennel. Treatment will also be given to take care of any emergency situations that may arise. All fees must be paid prior to your pet being discharged from the boarding facility.

### **Vaccinations**

Proof of current vaccinations must be presented at the time your pet is admitted for boarding. In the absence of such proof, your pet will be vaccinated and your account will be charged for the administration of any required vaccines. Vaccinations required include an Annual Distemper Booster, Rabies, and Bordetella (for dogs).

### **External Parasites**

Upon admission to the boarding facility, your pet must be free from all external parasites such as fleas, ticks, and/or earmites. As parasites are highly transmittable, your pet will be treated with Frontline and/or Acaress if necessary, and your account will be charged accordingly.

### **Health and Safety**

All possible precautions will be taken to ensure the wellbeing of your pet. However, it is impossible for us to predict how an individual animal will respond to the stresses of being boarded. In addition, some illnesses are airborne and are therefore difficult to control. Due to these factors, we can make no ethical guarantee or warranty in this regard. We will initiate treatment for any injury or illness that occurs while your pet is in our care. All customary fees will apply.

### **Personal Items**

We strive to efficiently handle personal items such as toys, blankets, food and treats; however, please be aware that we do not assume liability for items that are lost or damaged while your pet is boarding at the Airport Veterinary Clinic. Items must be properly labeled with the client's last name; consequently, those items not labeled will not be accepted at the time your pet is admitted.

### **Complimentary Bath**

Dogs boarding for more than 3 nights will receive a complimentary bath given the morning of discharge. Some animals respond nervously to this procedure and require sedation before being safely bathed. If necessary, your pet will be sedated and an additional fee will be applied to your account. If you prefer that your pet not be sedated, please inform our staff, but be aware that your pet will not be bathed before discharge.

### **Stress Colitis**

Your pet's health and happiness is our primary concern. It is not uncommon for animals to develop stress colitis (diarrhea) when boarding. Changes in your pet's environment or daily routine can often cause this condition. If left untreated, stress colitis can result in dehydration, weight loss, and depression. Our policy in treating stress colitis is to check a stool sample to rule out parasites, change the diet to a bland, high-fiber diet, and dispense medication to treat diarrhea. Unless there are further problems, we do not normally contact you in the event that your pet develops stress colitis. Please be sure to leave an accurate phone number so we can inform you of any other problems and proposed medical treatment.

**I understand that my pet may develop stress colitis while boarding and authorize the staff to treat for colitis if necessary; all costs associated with treatment are my responsibility.**

**I understand that my pet will be discharged from the boarding facility between 1:30 and 5:30 pm. If my pet is released before this time, I understand he/she may not be bathed.**
